PROGRAM RULES & EXPECTATIONS

- Transportation is currently provided from Burr, Cabot, Franklin, and Lincoln-Eliot Schools.
- A \$200.00 dollar, deposit must accompany each application to reserve a transportation spot for your child(ren). This deposit will be applied towards your first month of services and it is not refundable. Four weeks written notice required to withdraw your child from the program. Payment by the parent/guardian is due for the notice period.
- Transportation services are offered on a pre-payment basis. You will receive a statement at the beginning of each month. We reserve the right to withhold service during any month in which a payment is not made.
- Transportation services provide a ride from school to The John M. Barry Boys & Girls Club on all days when school is in session. It does not provide a ride from school to home or from the Club to home at the conclusion of the day.
- If your child will not be attending school or will not need to be picked up, you **must** call the Club at (617) 630-2066.
- If your child misses the bus, the school will be instructed to notify you. We will not guarantee a second trip if child does not arrive at the designated pick up point on time.
- Transportation applications are accepted on a first-come, first-serve basis.
